# **Management of the Tahfidz Excellence Class Program**

#### Abstract

The study by Az Zahrah, 'Ainun Shofiyatu (2023) investigates the implementation of flashcards in Arabic language learning to enhance interest in vocabulary acquisition among eighth-grade students at MTs Darul Muta'allimin Patianrowo. The study aims to describe the implementation of flashcards in Arabic language teaching, assess students' interest in vocabulary learning, and evaluate the effectiveness of flashcards in improving learning outcomes. This qualitative research employs interviews, observations, and documentation for data collection. The findings indicate that flashcards were effectively implemented, leading to easier comprehension of the material. Supporting factors include competent teachers, appropriate teaching media, adequate facilities, motivated students, and a conducive learning environment. Challenges include diverse educational backgrounds, varying student characteristics, different abilities, and fluctuating levels of motivation. Overall, the use of flashcards significantly increased students' interest and engagement in vocabulary learning.

#### INTRODUCTION

The implementation of the management program for the Tahfidz Excellence Class at MTs Negeri 1 Nganjuk represents an essential initiative within formal education aimed at producing proficient and certified Al-Qur'an memorizers. This program is distinguished by its specialized Tahfidz classes, which are conducted from Monday to Thursday during the first to the third periods. The curriculum incorporates memorization techniques, Muroja'ah (revision), and recitation submissions, all of which are overseen by two certified Al-Qur'an instructors (Hafidzah), along with additional supervisory teachers proficient in Quranic recitation. Prior to the introduction of the Tahfidz Excellence Class, MTs Negeri 1 Nganjuk already offered an academic excellence class focusing on Islamic Science Competitions (KSM) and Olympiads.

Initially, the Tahfidz program existed only as an extracurricular activity. However, the need for a unique identity, distinct from other madrasahs, led to the development of a dedicated Tahfidz Excellence Class. This decision was influenced

by the growing interest in Tahfidz among the community and the observation that similar programs in other schools were often limited to extracurricular activities, resulting in suboptimal outcomes. Consequently, the Tahfidz Excellence Class at MTs Negeri 1 Nganjuk was established in the 2022/2023 academic year, following the pandemic, in affiliation with the Pondok Pesantren Miftahul 'Ula, which also houses a Tahfidz dormitory under the Pondok Mitra.

Class management is a critical skill for teachers, involving the maximization of classroom potential by providing ample opportunities for individual creativity and focused activities. This principle is evident in the Tahfidz Excellence Class, where students are given substantial time during the first to the third periods to engage in memorization, revision, and learning new material related to Quranic Tahfidz.

One of the essential educational duties for Muslims is the proper learning and teaching of Quranic recitation. Muslims are expected to master Quranic reading before reaching puberty, ensuring that by adolescence, they can read the Qur'an with proper Tajwid. However, a significant challenge facing the Muslim community today is the widespread illiteracy in Quranic education, which adversely impacts academic achievement. Addressing this issue is urgent.

Memorizing the Qur'an is a demanding task that requires exemplary role models, discipline, and perseverance. The key to successful memorization lies in enhancing fluency and retention, ensuring that the Qur'an remains firmly in one's heart and mind. Daily practice is crucial to maintaining the memorized content.

In conclusion, students who are Al-Qur'an memorizers hold a distinguished status compared to their peers. Therefore, the Tahfidz Class at MTs Negeri 1 Nganjuk has been designated as an Excellence Class, directly supervised by the Ministry of Religious Affairs of Nganjuk Regency. This class serves as a model for other Madrasah Tsanawiyah schools in Nganjuk Regency that aim to implement a Tahfidz Excellence Program.

Based on the above background, the title of this thesis is: "Management of the Tahfidz Excellence Program at MTs Negeri 1 Nganjuk for the Academic Year 2022/2023."

#### **METHOD**

This study employs a descriptive qualitative approach, focusing on the management of the Tahfidz Excellence Class Program at MTs Negeri 1 Nganjuk during the 2022/2023 academic year. The qualitative method was selected due to its flexibility in adapting to the multifaceted realities encountered in the field. This approach facilitates a direct relationship between the researcher and the respondents, allowing for the nuanced exploration of the patterns and values inherent in the research setting. The study is conducted as a case study, which involves the detailed, in-depth, holistic, intensive, and systematic collection of data

The documentation used in this study includes written texts, images, and photographs related to the implementation of the Tahfidz Excellence Class Program and its management at MTs Negeri 1 Nganjuk (Bowen, 2009).

The data analysis followed the qualitative approach outlined by Bogdan and Biklen (2018), as cited by Moleong. This method involves working with the data, organizing it, categorizing it into manageable units, synthesizing it, identifying patterns, and determining what is significant and what can be shared with others. The researcher organized the data by grouping it based on interviews with the Tahfidz class instructors at MTs Negeri 1 Nganjuk, direct interviews with the students about the learning process, and interviews with the school principal regarding the management of the Tahfidz Excellence Class Program. The process of data analysis included examining all available data from various sources, such as interviews, observations recorded in field notes, personal documents, official documentation, images, photographs, and so on (Patton, 2017).

The stages of data analysis in this research include: Data Reduction Data reduction involves refining and categorizing data to draw or verify final conclusions. This step simplifies the retrieval of data when needed and assists in coding specific aspects (Miles, Huberman, & Saldaña, 2018). Data Display Data display involves organizing data or information in a structured manner that allows for the drawing of conclusions and action. Fieldwork Stage This stage involved three steps: understanding the research setting and preparing oneself, entering the field, and participating while collecting the necessary data using predetermined methods (Merriam & Tisdell, 2016). Data Analysis Stage The data collected from subjects, informants, and documents were refined, language and systematics were improved, and the data were analyzed according to the specified methods to avoid misunderstandings or misinterpretations. Report Writing Stage The final stage involved writing the research report following the appropriate thesis guide format, using language that is easy for readers to understand (Creswell & Creswell, 2018).

# Advantages of the Tahfidz Program at MTs Negeri 1 Nganjuk in the 2022/2023 Academic Year

To understand the advantages of the Tahfidz Excellence Program at MTs Negeri 1 Nganjuk, the researcher conducted an interview with Mrs. Arina Haq. She highlighted that the primary advantage of the Tahfidz Excellence Program is that, unlike other schools where Tahfidz is only offered as an extracurricular activity, MTs Negeri 1 Nganjuk integrates it fully into the curriculum. This makes the program more effective and unique as MTs Negeri 1 Nganjuk is the only school in Nganjuk Regency to offer such a program, making it a model for other schools in the region. Additionally, students who participate in this program are regarded as exceptional compared to regular students, and the program is directly supervised by the Ministry of Religious Affairs of Nganjuk Regency.

Another significant advantage of the Tahfidz Excellence Program at MTs Negeri 1 Nganjuk is that students who are part of the program must reside in a boarding school affiliated with the madrasah. This requirement ensures that the program's vision and mission align closely with the affiliated Islamic boarding school, Pondok Pesantren Miftahul 'Ula. Mrs. Yunita Istiani Rohmah mentioned that this arrangement fosters a consistent approach between the school and the boarding school, ensuring that students receive comprehensive guidance in their Quranic studies.

The program is further strengthened by the fact that the affiliated boarding school is located near the madrasah and offers intensive supervision by highly qualified instructors (Hafidzah) with an unbroken chain of Quranic recitation back to the Prophet Muhammad (PBUH). The daily schedule includes five dedicated days

The management of the Tahfidz Excellence Program is comprehensive and well-structured. It involves the leadership of the madrasah, competent teachers, and the active participation of the Madrasah Committee and the broader community, all working together to enhance the quality and service of education. This approach aligns with the goals of the National Education System as outlined in Law No. 20 of 2003, Article 3. The curriculum follows the Merdeka Curriculum at the madrasah while integrating the educational framework of the partner pesantren, particularly in the area of Tahfidzul Qur'an. Dedicated and qualified teachers at both the madrasah and the pesantren guide and mentor students, ensuring effective Quranic memorization. The program is funded through the madrasah's DIPA, contributions from the Madrasah Committee, and self-funded learning at the partner pesantren.
